Post Name Change Instructions – Minors in NYC and NYS

Congratulations on legally changing your child's name! Now that you have changed your child's name through the court, you will need to make sure that government agencies and private entities are aware of the new name.

A certified copy of the name change order is the document you will use as proof of the new name. In general, do not give away certified copies of your name change order. Show the order and take it back or provide a photocopy. If photocopying the name change order, **do not remove the receipt or the staples**. It invalidates the certification. Print out the scanned PDF instead.

Schools

Show the registrar's office a copy of the name change order. Oftentimes schools that have updated records previously will maintain the legal name in a private file, so provide a photocopy of the name change order and make sure they completely update their records. Also request that the sex be updated on all records, if applicable. They will probably want to see a corrected passport or birth certificate to do so.

If a public school refuses to update a record, inform them they are obligated to comply with a name change order under [§ 64\(3\) of the New York State Gender Recognition Act](#). If they continue to refuse, you can [file a complaint](#) with the New York State Division of Human Rights (or if the school is in NYC, the [New York City Commission on Human Rights](#)).

Health insurance

You can write a letter to the insurance company and include a photocopy of the name change order. You can call the number on your card to find out what documentation they require to change the sex designation. You may be asked to provide a corrected birth certificate, or they may automatically update the sex designation when they update the name. Make sure that doctors' offices submit bills under the corrected name and sex designation. As with public schools, insurers are obligated to comply with a name change order and should not be requiring additional documentation (like an updated photo ID) before changing their records.

Note: It is unlawful in New York for an insurer to deny coverage for sex-specific care based on the gender marker they have on file. If coverage for sex-specific care is denied, call your insurance company and tell them about the error. They will be able to add a code to your

file to make sure you are not denied in the future. If the problem continues, [file a complaint with the New York State Department of Financial Services](#).

Social Security

Note 1: Under COVID-19 procedures, Social Security is closed to non-emergency in-person services. All name and gender marker changes are being done by mail.

Note 2: Social Security will return your originals to you before you receive your actual card; this means your request has been processed. You do not need to wait for your actual card to change other documents in most cases.

X gender markers are currently not available on Social Security records. The Social Security Administration has put out guidance instructing employees to accept documents with X markers as proof of identity for purposes of establishing a new Social Security number, so new parents who choose to designate X on their child's birth certificate are now able to obtain an initial Social Security number for the child using their X birth certificate, but the record itself must say M or F.

By mail: Mail your SS-5, certified copy of a name change order, original doctor's letter (if changing gender marker), and [this](#) internal guidance *with Section D highlighted*, and a photocopy of your ID to your Social Security office. You do *not* need to include ID because the name change order is an proof of identity. Find your local Social Security office [here](#).

People who live in NYC must use a Card Center to get a replacement card, although it need not be the one in your borough. These are the best offices to go through:

Mail the following documents to the office:

- A completed SS-5 form (see below for instructions on filling this out);
- A certified copy of your name change order (they look at it but do not keep it);
- Doctor's letter to change the sex (refer to attached sample letter) or passport or birth certificate with the correct sex, if applicable;
- Photocopy of unexpired photo ID, such as a drivers' license, state ID, or passport (can be in your old name);
- [This](#) internal guidance *with Section D highlighted*.

Filling out the form

- ✓ Use Form SS-5, Application for a Social Security Card, the same form used for applying for a new card. They have the forms at the office, so fill it out while you wait, or you can download it [here](#).
- ✓ In the first blank, “name to be shown on card,” put your new legal name. List your name at birth on the line below that.
- ✓ Leave the “other names used” section blank unless you have changed your name legally before.
- ✓ Select the new sex if you have the letter from your doctor.
- ✓ You do not need to list your parents’ Social Security numbers.

Ask to speak with a supervisor if there is any problem. The change is effective within 24 hours, and you will receive your new Social Security card in the mail in about 2 weeks. There is no cost.

Changing a Social Security number

Your number will remain the same. Social Security numbers are typically changed only when one can present evidence documenting harassment or abuse. You can apply at your local office. Visit <http://ssa.gov/pubs/10093.html> for more information.

DMV – non-driver ID, permit, or license

Persons of any age can get a non-driver ID card. If your child does not have another form of ID in their name, it can be helpful to get them an ID card with the corrected name and gender. If applying for a New York non-driver state ID or driver’s license for the first time, you can simply wait until you get the corrected birth certificate or passport to apply. You will need to present the child’s Social Security card and a birth certificate or a passport. Visit <https://dmv.ny.gov/id-card/bget-non-driver-id-card-ndid> for information about how to obtain an ID card for a minor.

To change your driver’s license or NY state ID, visit a local DMV branch. Branches are requiring an appointment at this time: <https://dmv.ny.gov/offices/dmv-office-locations>.

Note: Due to the Real ID Act, the DMV may tell you that you need to update Social Security before they will update DMV records, but that is not the case. If you are told you must update Social Security first, ask to speak with a supervisor – your name change order should be satisfactory.

Bring the following documents:

- ❑ Proof of your child’s identity.
 - If your child already has a New York State driver license or ID card (current or expired less than two years ago), that is all you need to get a new ID.
 - If your child does not currently have a NY license or ID, you will need their Social Security card, proof of date of birth, and four “points” worth of ID or a

[parental statement of identity](#). To avoid a wasted trip, review the [ID requirements](#) before going to the DMV.

- Proof of identity can be in the old or new name.
- A certified copy of the name change order (they will give it back to you).
- A completed Form MV-44, which you can obtain at the DMV or you can download the form [here](#). Fill out the form using the new name and gender.
- In the Identification Information section of Form MV-44, check the box corresponding to the corrected sex. Then, if the child has had an ID before, in the box marked Other Change, write that you are changing the sex. You no longer need a doctor's letter to change the sex designation on your DMV ID.

The DMV will give you a new temporary non-photo ID right away and will mail you the permanent one in two to six weeks.

X gender markers are currently not available on NY DMV-issued IDs but they are expected to be available in May/June 2022.

IDNYC card

To change the name on a NYC municipal ID card, make an appointment at any [enrollment center](#) and bring your child's old card along with a certified copy of your child's name change order. The gender on an IDNYC card is self-designated, so you can change it without a doctor's letter. Options include male, female, nonbinary (X), and no designation. The IDNYC card is available to New York City residents ages 10 and up.

U.S. Passport: an alternative to a birth certificate

If you are unable to update the sex on the birth certificate, you can use a passport in many situations where you might need to show a birth certificate. You can get the sex designation changed on a passport by self-attestation (filling out the appropriate marker on the form). The State Department no longer requires a doctor's letter, surgery, or hormones. X gender markers are currently not available on passports but the State Department anticipates that they will be available in 2022.

All requests to update the sex designation on a passport must use Passport Application Form DS-II regardless of whether your child already has a passport already or not. (Do not sign the form until instructed to do so.)

Global Entry and TSA Pre✓

For children who will be travelling regularly, consider having all family members get Global Entry cards, which cost \$100 each and are valid for 5 years. In addition to streamlining the return from international travel, it enables you to enroll in TSA Pre✓, which allows you to bypass the body scanners (and long security lines). If you will not be travelling internationally, you can enroll in TSA Pre✓ by itself for \$85 for 5 years.

Wait to apply until after you get the corrected passport. You will need to go in person to have a photo taken and be fingerprinted. Begin by applying online: <https://ttp.cbp.dhs.gov>.

If your child already has a Global Entry card, you must visit a [Global Entry enrollment center](#) to update their name and gender in the system in addition to updating their passport. You can log into your account and confirm that they've updated it.

It is not necessary to update the physical card because it does not ever need to be presented anywhere, but it can be used instead of a passport for land and sea entries. If you wish to change the physical card, call to make an appointment (212) 344-2296. The new card fee is \$25.

Other places to change your child's name

You will need to change your child's name with places like doctors' offices, libraries, banks, credit cards, student loans, etc. You can change the name at these places by visiting them in person and presenting a copy of the name change order or by writing letters.

When writing a letter, include your address and any account numbers, and request that they change your child's name from the old name to the new one. Enclose a photocopy of the name change order. Most businesses do not require a certified copy.

Beneficiary documents, savings bonds, 529 & estate planning documents

It's best to change your child's name where it appears in wills or is listed as beneficiary for IRA, life insurance policy, etc.

To change the name on a 529 or a trust account, send a letter requesting the change and a copy of the court order. Some banks may require the account owner to physically come in to make

the change.

The name on savings bonds does not need to be changed. At the time of cashing, sign as “New Name changed by court order from Old Name.” Be prepared to produce the name change order. Reissuing a savings bond may mean owing taxes. [Form 4000](#) is used to have bonds reissued in the new name, which will be done electronically only.

Getting additional copies of the name change order

You will probably not need any additional certified copies (do not give them away lightly). However, you can obtain additional certified copies of your name change order from the clerk’s office in the county where the order was issued. Name change files that have been sealed require getting a temporary unsealing order if the requestor is not the petitioner (and sometimes even if it is), so it is best to avoid giving away certified copies. Contact charlie@arrowood.law if you need a sample unsealing request.

For NYC name changes: If the file is not sealed, you can go to the clerk’s office in-person or send a letter to County Clerk, New York County Civil Court, 111 Centre Street, New York, NY 10013 requesting certified copies of the name change order. The letter should include the index number, the name of the case, and the number of copies you would like. Each copy is \$6 and can be paid via certified check or money order payable to “Clerk of Court.” You also need to include an envelope with your return address and sufficient postage so that they can mail you the copies. You can reach the clerk at (646) 386-5609.

For name changes outside NYC: If the file is not sealed, you can go to the clerk’s office in-person or send a letter to the clerk’s office where you filed the name change. The letter should include the index number, the name of the case, and the number of copies you would like. Most counties charge \$5 per certified copy, but call your county clerk first to confirm the exact amount and what type of payment they accept.

Sample Doctor's Letter for Sex Designation Changes

This letter meets federal requirements to change the sex designation with Social Security and on immigration documents. It does **not** need to be notarized.

NOTE: Currently, an X gender marker is **not** available on NY state photo IDs (until May/June 2022) or federal documents (availability on passports is anticipated in 2022). An X gender marker is available on NY State and New York City birth certificates, and the IDNYC Card. The gender marker on New York City and NY state birth certificates can be changed by self-attestation (without a doctor's letter) using the designated forms, available [here](#).

Sample letter meeting federal government requirements:

Date

I, [Physician's Full Name], am the physician of [Chosen Name of Patient a/k/a Current Legal Name], DOB: [Date of Birth], with whom I have a doctor/patient relationship and whom I have treated [or with whom I have a doctor/patient relationship and whose medical history I have reviewed and evaluated].

[Chosen Name of Patient] has had appropriate clinical treatment for gender transition to the new gender of [specify male or female].

I declare under penalty of perjury under the laws of the United States that the forgoing is true and correct.

Requirements for this letter:

- Printed on **letterhead** that includes:
 - Physician's address
 - Telephone number
- Signed by an **MD** or **DO**
- Provide **three original copies** to the patient.
 - Photocopies and scans are not acceptable.
 - Ideally, sign in blue ink

Sample Letter Requesting a Private Entity to Change Your Name

*When writing to private entities, use only a **photocopy** of the name change order, not a certified copy.*
